EXECUTIVE ORDER NO. 19-A s. 2017

AN ORDER CREATING MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC), MUNICIPAL PEACE AND ORDER (MPOC) AND MASA-MASID TECHNICAL WORKING GROUP (TWG) IN SUPPORT TO THE ANTI-ILLEGAL DRUG ABUSE PROGRAMS, PEACE AND ORDER AND PUBLIC SAFETY PROGRAMS AND MASA MASID (MAMAMAYANG AYAW SA ANOMALYA, MAMAMAYANG AYAW SA ILEGAL NA DROGA) PROGRAM THIS MUNICIPALITY.

WHEREAS, Section 116 of RA 7160, otherwise known as the Local Government Code of 1991 mandates the establishment in every province, city and municipality of a local peace and order council pursuant to Executive Order No. 309, as amended, series of 1988;

WHEREAS, Executive Order No. 773 series of 2009 further reorganized the peace and order council of which the membership at the national, regional and local levels expanded;

WHEREAS, Comprehensive Dangerous Drugs Act of 2002" (Republic Act 9165) - protects the state and its individuals from the possible harms brought about by the abuse of illegal drug substances;

WHEREAS, DILG Memorandum Circular No. 2015-63 or the "Revitalization of the Barangay Anti-Drug Abuse Councils (BADAC) and their Role in Drug Clearing Operations" which reinforces the mandate of the barangays to "adopt measures towards the prevention and eradication of drug abuse, etc." (Section 391, a20 of the LGC of 1991);

WHEREAS, as a strategy, it shall mobilize and converge said Technical Working Group to advocate crime prevention, peace and order, security, and in enhancing transparency and accountability in the barangay. It will also serve as collaborative body of all Local Special Bodies: MPOC, MADAC, MCPC, LCAT-VAWC etc.;

NOW THEREFORE I, SHARON ROSE G. ESCOTO, Municipal Mayor of the municipality of GUBAT, province of Sorsogon, by virtue of the power vested in me by law, do hereby order and direct the following:

Section 1. Creation of the said Technical Working Group:

Section 2. Duties and Functions:

1. Oversee the implementation of related and mandated programs
2. Encourage a health relationship within and among all partners
3. Ensure a close coordination with the concerned agencies
1. Convene and mobilize the Teams in relation to said mandated programs

3. Conduct regular monitoring of the activities
4. Consolidate reports submitted by the Barangay teams
5. Implement systematic monitoring and reporting mechanism
6. Maintain the local hotline lodged at the Local Police Station
7. Provide the appropriate technical and administrative assistance to the program

Section 3. FUNDING. Funding for the operation will be charged to other services/Mayor's Office.

Section 5. EFFECTIVITY. This order shall take effect immediately.
