EXECUTIVE ORDER NO. 2020 - 010

AN ORDER CREATING THE MUNICIPAL AWARDS COMMITTEE FOR THE ANNUAL LUPONG TAGAPAMAYAPA INCENTIVES AWARDS (LTIA) PROGRAM

WHEREAS, Section 16 of the LGC of 1991 specifically mandates all local government units to ensure and maintain peace and order within their respective areas of jurisdictions, among other concerns;

WHEREAS, Executive Order No. 394 daetd January 22, 1997, established the Annual Lupong Tagapamayapa Incentives Awards (LTIA) aims to accord official recognition and tribute to Lupons for reasons of exemplary performance in the implementation of the Katarungang Pambarangay at the grassroots;

WHEREAS, DILG MC No. 2008-012 dated June 17, 2008, as enhanced by the DILG MC No. 2016-58 dated April 29, 2016 provides for the guidelines for the Lupong Tagapamayapa Incentives Awards (LTIA);

WHEREAS, under the above mentioned guidelines (DILG MC No. 2016-58), all Lupons nationwide are covered by the annual awards;

NOW, THEREFORE, I, SHARON ROSE G. ESCOTO, Mayor of the municipality of Gubat, province of Sorsogon, by virtue of the power vested in me by law do hereby order and direct the following:

SECTION 1. CREATION OF THE MUNICIPAL AWARDS COMMITTEE FOR THE ANNUAL LUPONG TAGAPAMAYAPA INCENTIVES AWARDS (LTIA) PROGRAM. The Municipal Awards Committee for the Annual Lupong Tagapamayapa Incentives Awards (LTIA) Program is hereby reorganized with the following composition:

SECTION 2. DUTIES AND FUNCTIONS. The Municipal Awards Committee for LTIA shall perform the following duties and functions:


1. Initiate and coordinate the necessary activities towards the successful implementation of the LTIA in the Municipality;
2. Disseminate information on the Awards to generate awareness and support from the public and private sectors within the municipality;
3. Select and submit to Provincial Awards Committee the best performing lupon within the municipality;
4. May secure funding and counterpart prizes from the partner agencies and the private sector; and
5. May plan and implement appropriate awarding ceremonies.

SECTION 3. AUTOMATIC SUCCESSION OF MEMBERS. In case of resignation, retirement, separation, transfer, re-assignment, removal of a member, the successor or replacement shall automatically take the position and serve only for the unexpired term. Provided, that in case of leave or suspension, the replacement shall serve only for the duration of the leave or suspension.

SECTION 4. REPEALING CLAUSE. All prior local issuances, orders, rules and regulations inconsistent herewith are hereby repealed or modified.

SECTION 5. EFFECTIVITY. This order shall take effect immediately.
