**AN ORDER PRESCRIBING THE GUIDELINES FOR THE LOCAL MANAGEMENT  
OF THE CORONAVIRUS DISEASE 2019 (COVID-19) SITUATION IN THE  
MUNICIPALITY OF GUBAT**

**WHEREAS**, numerous directives have been issued by the various National Government Agencies in relation to the management of the COVID-19 disease;

**WHEREAS**, there is a need to set in place a uniform guideline in order to prevent confusion without compromising the delivery of basic services;

**NOW THEREFORE, I, SHARON ROSE G. ESCOTO**, Municipal Mayor of Gubat, Sorsogon by virtue of the power vested in my by law, do hereby order the following:

**Section 1. General Provision.** That pursuant to the provisions of Proclamation Nos. 929 and 922(s.2020) and Republic Act No. 11332 as provided for under the guidelines issued by Executive Secretary Salvador C. Medialdea dated March 16, 2020 hereto attached as **Annex A** shall be **strictly implemented**.

**Section 2. Home Quarantine Pass**

1. That every barangay may issue a non-transferable Home Quarantine Pass duly signed by the Punong Barangay or in his absence of unavailability by next highest ranking barangay kagawad for only one (1) person per every household.

2. That the barangay shall maintain a logbook indicating the names of the person issued a Home Quarantine Pass and the date of issue. It shall also be indicated in the logbook the date and time the individual issued a pass exited the barangay and the date and time he/she returned back to the barangay.

3. That said Home Quarantine Pass shall be checked/stamped at the checkpoint indicating the date and time the individual passed through said checkpoint and the purpose/reason why the said individual obtained a pass from the barangay.

4. That the Home Quarantine Pass can be used two (2) times per day only.

**Section 3. P2P Transport**

1. Transportation of health personnel/front-line personnel working in Sorsogon City without any means of travelling to their place of work can avail of free transportation from Gubat to Sorsogon City subject to the trip schedule of the shuttle on stand-by at the municipal compound hereto attached as **Annex B**.

**Section 4. Transportation for health workers/frontline personnel.** All health workers/front-line personnel of the local government unit including those in the barangay shall be provided free transportation. The municipal compound of the local government unit shall serve as the transportation hub where the service vehicle that would ferry them to their station would be in stand-by mode.

**Section 5. Transportation for persons needing medical attention.** Persons needing medical attention without any means of transportation to the hospital or health facility shall be transported by the ambulance or shuttle provided by the local government unit.

**Section 6. Operation of mass transportation.** Operation of PUB, PUJ, Tricycle for hire and all other modes of mass transportation are all suspended. Only private motor vehicle/shuttle commissioned by the local government unit to deliver basic services shall be allowed to operate.

**Section 7. Repealing Clause.** These guidelines supersedes all executive orders issued by the local government unit of Gubat, Sorsogon and may be changed or amended from time to time.

**Section 8. Incorporation Clause.** All laws, legal order, rules, and regulations that have been issued and/or will be issued by the duly constituted authorities of the Republic of the Philippines pertaining to public health and COVID-19 are hereby incorporated herein and made an integral part hereof.

**Section 9. Effectivity.** This order shall take effect immediately.


