EXECUTIVE ORDER NO. 2020- 15 - A

AMENDING CERTAIN PROVISIONS OF EXECUTIVE ORDER NO. 2020-15

WHEREAS, on April 30, 2020 this office issued Executive Order No. 2020-15 entitled "Providing Further Guidelines For The Local Implementation Of Particular Provisions Of Executive Order No. 37-2020 Issued By Governor Francis Joseph G. Escudero.";

WHEREAS, there is a need to revisit some of the provisions of the said Executive Order relative to public transportation sector;

NOW THEREFORE, I, Sharon Rose G. Escoto, Municipal Mayor of Gubat, Sorsogon by virtue of the power vested in my by law, do hereby order the following:

Section 1. Operation of Tricycles-Tricycles with existing MTOP shall operate on alternate schedule. To prevent confusion, stickers bearing numbers 1 and 2 shall be installed in every tricycle. All tricycles bearing stickers number 1 shall operate on the same day while tricycles bearing sticker no. 2 shall operate on the following day. The respective TODA's shall take charge in the installation of said stickers in every tricycle and shall manage the alternate scheduling of their respective members in order to maintain 50% operation per route per day.

Section 2. Parking area-All tricycles shall park in their designated area indicated in the attached sketch plan which is made an integral part of this Executive Order.

Section 3. Operation of Public Utility Jeepneys (PUJ's)- All PUJ's shall observe all guidelines relative permit to operate, passenger capacity and health protocols issued by the IATF or by any competent authorities.


Section 4. Incorporation Clause-All laws, legal orders, rules and regulations that have been issued and/or will be issued by the duly constituted authorities of the Republic of the Philippines in relation to COVID-19 and the General Community Quarantine (GCQ) are hereby incorporated herein and made an integral part hereof. In case of conflict, such laws, legal orders, rules and regulations shall have precedence over the provisions of this Executive Order.

Section 5. Repealing Clause-Any Executive Orders previously issued that are inconsistent to the provisions of this Executive Order is considered repealed, amended and modified accordingly.

Section 6. Effectivity. This order shall take effect immediately and shall remain valid and effective unless otherwise amended, repealed or modified accordingly.
