### EXECUTIVE ORDER NO. 2020-15 - B

## PROVIDING ADDITIONAL GUIDELINES IN THE OPERATION OF PUBLIC UTILITYJEEPNEYS IN THE MUNICIPALITY OF GUBAT, SORSOGON

**WHEREAS**, on April 30, 2020 this office issued Executive Order No. 2020-15 entitled "Providing Further Guidelines For The Local Implementation Of Particular Provisions Of Executive Order No. 37-2020 Issued By Governor Francis Joseph G. Escudero.";

**WHEREAS**, there is a need to revisit some of the provisions of the said Executive Order relative to public transportation sector;

**NOW THEREFORE, I**, Sharon Rose G. Escoto, Municipal Mayor of Gubat, Sorsogon by virtue of the power vested in my by law, do hereby order the following:

Section 1. Operation of Public Utility Jeepneys (PUJ's)- All PUJs or units that have complied with the requirements set by the Omnibus Franchising Guidelines (OFG) of LTFRB shall be allowed to ply the approved route/ organization, to wit:

- 1. Gubat to Sorsogon City, vice versa
- 2. Gubat to Prieto Diaz, vice versa
- 3. Gubat to Barcelona, vice versa
- 4. Gubat to Casiguran, vice versa
- Section 2. Compliance to Minimum Health Standard Protocols. The passenger load of each jeepney must not exceed 50 percent (50%) of its seating capacity (excluding the driver) and must consider minimum health standards such as, but not limited to recording of passengers for possible contact tracing, wearing of face masks and face shield at all times, observing social distancing, regular disinfections of units.

**Section 3. Queuing of Passengers**. Public Utility Jeepneys (PUJs) plying the Gubat - Sorsogon City route shall have separate lanes - one lane for the non-air-condition jeepneys and another lane for air conditioned jeepneys at the PAMANA terminal.

**Section 4. Incorporation Clause** - All laws, legal orders, rules and regulations that have been issued and/or will be issued by the duly constituted authorities of the Republic of the Philippines in relation to COVID-19 and the General Community Quarantine (GCQ) are hereby incorporated herein and made an integral part hereof. In case of conflict, such laws, legal orders, rules and regulations shall have precedence over the provisions of this Executive Order.

**Section 5. Repealing Clause -** Any Executive Orders previously issued that are inconsistent to the provisions of this Executive Order is considered repealed, amended and modified accordingly.

**Section 6. Effectivity.** This order shall take effect immediately and shall remain valid and effective unless otherwise amended, repealed or modified accordingly.
