



**EXECUTIVE ORDER NO. 2020 – 016**

**PROVIDING FURTHER GUIDELINES FOR THE LOCAL  
IMPLEMENTATION OF PARTICULAR PROVISIONS OF  
EXECUTIVE ORDER NO. 37-2020 ISSUED BY  
GOVERNOR FRANCIS JOSEPH G. ESCUDERO**

**WHEREAS**, on April 30, 2020, Governor Francis Joseph G. Escudero issued Executive Order No. 37-2020 entitled "PROVIDING FOR GUIDELINES IN THE IMPLEMENTATION OF A GENERAL COMMUNITY QUARANTINE (GCQ) IN THE PROVINCE OF SORSOGON AND FOR OTHER PURPOSES";

**WHEREAS**, Section 11 of the aforementioned Executive Order No. 37-2020 provides that private and public transport which shall include vehicles, trucks, tricycle, padyak, motorcycle, jeepneys, UV express and buses shall be allowed to travel and operate under a reduced capacity;

**WHEREAS**, Sec. 11, paragraphs c and f provides that tricycles and jeepneys shall operate at a reduced capacity of not more than fifty percent (50%) of the total tricycles per route, including "round-round" and fifty percent (50%) of the total jeepneys per route in accordance with regulations issued by the LGU concerned;

**NOW THEREFORE, I, SHARON ROSE G. ESCOTO**, Municipal Mayor of Gubat, Sorsogon by virtue of the power vested in my by law, do hereby order the following:

**SECTION 1. Operation of Tricycles-**ALL Public Utility Tricycles shall be allowed to operate based on the following schedules as follows:

<b>MUNICIPAL PLATE NUMBER ENDING</b>	<b>DAYS ALLOWED TO OPERATE</b>
<b>1,3,5,7,9</b>	Monday, Wednesday, Friday (MWF)
<b>2,4,6,8,0</b>	Tuesday, Thursday and Saturday (TThS)
<b>ALL TRICYCLES CAN OPERATE DURING SUNDAYS</b>

**SECTION 2. Parking area-** ALL tricycles shall park in their designated area as follows:

<b>ROUTE/ORIGIN</b>	<b>DESIGNATED PARKING AREA</b>
TRICYCLES FROM SOUTH BARANGAYS	<ol style="list-style-type: none"><li>1. From corner Manook Street and Mabini Street towards corner Quezon Street and Mabini Street;</li><li>2. From Market exit along Zulueta Street to corner Zulueta and Mabini Street</li></ol>
TRICYCLES FROM NORTH BARANGAYS	<ol style="list-style-type: none"><li>1. From Market exit along Zulueta Street to corner Herrera and Zulueta Sts;</li><li>2. From corner Herrera and Zulueta Sts to corner Herrera to Quezon Sts.</li></ol>
POBLACION TRICYCLES	<ol style="list-style-type: none"><li>1. From Market exit along Diaz St. to corner Diaz and Quezon Sts;</li><li>2. From corner Manook and Herrera Sts. (Yang Merchandise) to corner Zulueta and Herrera Sts.</li><li>3. From corner Luna and Zulueta Sts. to part of Zulueta;</li><li>4. From corner Manook and Luna Sts. to corner Luna and Bonifacio Sts. (Poblacion and Sta. Ana Tricycles)</li></ol>

**SECTION 2.1. All unloading of deliveries shall be designated in the following locations:**

1. The stretch of Luna Street fronting Gubat Yek Hua Trading towards GSAC is designated as the DELIVERY AREA for DELIVERY TRUCKS ONLY.
2. Manook Street can be utilized by DELIVERY TRUCKS for DELIVERIES FROM 11:00 AM up to 3:00 PM ONLY.
3. Luna Street fronting Añesco and One-Stop-Shop can be utilized by DELIVERY TRUCKS for DELIVERIES FROM 11:00 AM – 3:00 PM
4. Corner Diaz and Zulueta Sts fronting Co warehouse can be utilized by DELIVERY TRUCKS for DELIVERIES FROM 4:00 PM to 7:00 PM;
5. Corner Diaz and Quezon Sts can be utilized by DELIVERY TRUCKS for DELIVERIES FROM 11:00 AM – 3:00 PM.

**SECTION 2.2.** Manook Street fronting the Gubat Public Market is designated as loading area of passengers carrying goods. Parking and/or Unloading of cargo and/or passengers is not allowed.

**SECTION 2.3.** Parking of single motorcycle shall be in front of the new public market building. Parking of private four-wheel vehicles shall be in front of the old public market building.

**SECTION 3. Operation of Public Utility Jeepneys (PUJ's)-** All PUJs granted with franchises shall be allowed to resume operation on reduced capacity. PUJs plying the Gubat- Sorsogon route shall observe rest day/s when they will not be allowed to operate based on the schedule as follows:

Gubat Transport Cooperative	MONDAY AND TUESDAY
Barcelona-Gubat Sorsogon Transport Cooperative	WEDNESDAY AND THURSDAY
RJ Line	FRIDAY AND SATURDAY
ALL PUJ'S CAN OPERATE DURING SUNDAYS	

All PUJs shall originate from the PAMANA Terminal for proper monitoring purposes (recording of passengers, wearing of masks, social distancing, disinfection, etc.)

**SECTION 4. Incorporation Clause.** All laws, legal orders, rules and regulations that have been issued and/or will be issued by the duly constituted authorities of the Republic of the Philippines in relation to COVID-19 and the General Community Quarantine (GCQ) are hereby incorporated herein and made an integral part hereof. In case of conflict, such laws, legal orders, rules and regulations shall have precedence over the provisions of this Executive Order.

**SECTION 5. Repealing Clause-**Any Executive Orders previously issued that are inconsistent to the provisions of this Executive Order is considered repealed, amended and modified accordingly.
