**EXECUTIVE ORDER NO. 2020 – 020**

**AN ORDER IMPOSING TEMPORARY LIQUOR BAN IN THE ENTIRE  
MUNICIPALITY OF GUBAT, SORSOGON AMID THE IMPLEMENTATION OF  
SOCIAL DISTANCING DUE TO COVID-19**

**WHEREAS**, Article 2, Section 15 of the 1987 Philippine Constitution provides that “the state shall protect and promote the right to health of the people and instill health consciousness among them”;

**WHEREAS**, Section 16 of the Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that “Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, numerous directives have been issued by the various National Government Agencies in relation to the management of the COVID-19 disease;

**WHEREAS**, the Local Government Unit of Gubat issued Executive Orders for the implementation of precautionary and mitigating measures as well as additional guidelines for COVID-19 response in the municipality;

**WHEREAS**, selling, serving and consumption of liquors and other similar intoxicating drinks encourages closes contact among people thereby defeating the objectives of community quarantine and social distancing;

**WHEREAS**, due to the increasing cases of COVID-19 and contacts to be traced, it has become more necessary to limit movements and social gatherings, including but not limited to drinking sessions, parties and the like.

**NOW THEREFORE, I, SHARON ROSE G. ESCOTO**, Municipal Mayor of Gubat, Sorsogon by virtue of the power vested in my by law, do hereby order the imposition of temporary liquor ban in the entire Municipality of Gubat, Sorsogon and further order the following:

**Section 1. Prohibition.**

- a. It shall be prohibited for any commercial establishments to sell or serve liquors, alcoholic beverages, and other similar intoxicating drinks;
- b. It shall be prohibited for any person to consume liquors, alcoholic beverages and other similar intoxicating drinks in mass gatherings and/or public places;

**Section 2. Penalties.**

1. Any establishment caught violating Section 1 (a) shall face revocation of Mayor's Permit and Business Permit;
2. Any person caught violating Section 1 (b) shall be penalized under Chapter VI, Article H of the Municipal Ordinance No. 2007-004; the Revised Penal Code of the Philippines and other existing laws whichever is applicable.

**Section 3. Effectivity and Duration.** This order shall take effect immediately and shall remain to be in full force and effect until lifted.






