**AN ORDER REORGANIZING THE MUNICIPAL INTER-AGENCY COMMITTEE (MIAC) FOR THE KAPIT-BISIG LABAN SA KAHIRAPAN – COMPREHENSIVE AND INTEGRATED DELIVERY OF SOCIAL SERVICES – NATIONAL COMMUNITY DRIVEN DEVELOPMENT PROGRAM (KALAHI-CIDSS-NCDDP)**
