

EXECUTIVE ORDER NO. 2020-37

AN ORDER CREATING THE TRICYCLE TASK FORCE OF THE MUNICIPALITY OF GUBAT, SORSOGON

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, has devolved to all cities and municipal governments, through their Sanggunians, the power to regulate the operation of tricycles/ pedicabs and to grant franchise for the operations thereof within their territorial jurisdiction;

WHEREAS, DOTC's Guidelines to Implement the Devolution of LTFRB's Franchising Over Tricycles-for-hire to Local Government Units Pursuant to the Local Government Code" in no unmistakable terms prohibited the operations of tricycles along national highways "where the Sanggunians may provide exception if there is no alternate routes";

WHEREAS, DILG Memorandum Circular No. 2020-04 dated 10 January 2020 was issued in response to President Duterte's directive to clear roads of illegal structures and obstruction and for the Sanggunian to review the guidelines in the issuance of franchise;

WHEREAS, DILG Memorandum Circular No. 2020-036 dated 17 February 2020 entitled Prohibiting Tricycles, Pedicabs and Motorized Pedicabs from Operating on National Highways;

WHEREAS, the same DILG MC provides for the creation of the Tricycle Task Force in every City and Municipality to formulate or revise its Tricycle Route Plan in their area of jurisdiction which is separate and distinct from the Tricycle Regulatory Board.



 are banned from national highways;
