EXECUTIVE ORDER NO. 2021-02

REORGANIZING THE LOCAL MARKET COMMITTEE OF THE MUNICIPALITY OF GUBAT

WHEREAS, Municipal Ordinance No. 2007 – 004 or the Code of General Ordinances, provides for the creation of the Market Committee which shall implement the approved Market Ordinance;

WHEREAS, the Gubat Public Market, is one of the viable economic enterprise of the municipality established for its self-reliance and viability, equipped with facilities for the services of the buying public;

WHEREAS, for the attainment of the objectives enunciated in the Market Ordinance, there is a need to create a body that shall implement, continue and better and better the delivery of services by the Municipality to its constituents through the Gubat Public Market;

NOW THEREFORE, I, SHARON ROSE G. ESCOTO, Municipal Mayor of the municipality of Gubat, Province of Sorsogon, by virtue of the power vested in me by law, do hereby order the creation of the Local Market Committee of this municipality;

SECTION 1. COMPOSITION. The Local Market Committee (LMC) shall be composed of the following:

SECTION 2. POWERS AND FUNCTIONS. The power and functions of Local Market Committee are the following:

1. Conduct the drawing of lots and opening of bids in connection with the adjudication of vacant or newly constructed stalls or booth in the public market, supermarket building, or any other municipal lots, for such purpose, and to certify to the Municipal Mayor the results thereof;
2. Formulate policies, rules and regulations for market operations and administration;
3. Conduct periodic review of public market operation;
4. Impose sanctions and penalties of violators in accordance to the ordinance;
5. Hear and settle grievances arising out of market operations and administration.

SECTION 3. TERM OF OFFICE. All members of the Local Market Committee shall hold office for the duration of the terms of the office to which they were elected or appointed. In the case of SB representatives, they shall hold office for as long as they are still the Chairperson of the respective SB committees, which they head.

SECTION 4. MEETINGS. The Local Market Committee shall have its regular meeting every quarter, however the Chairman may call a special meeting anytime for the purpose of taking up specific matters.

SECTION 5. REPEALING CLAUSE. All orders and issuances that are inconsistent with this order are hereby repealed or modified accordingly.

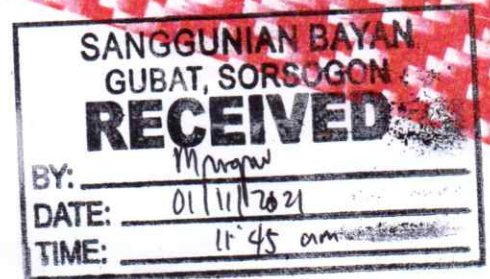
SECTION 6. EFFECTIVITY. This order shall take effect immediately.
