



EXECUTIVE ORDER NO. 2021 – 014-A

AN ORDER AMENDING CERTAIN GUIDELINES FOR THE LOCAL IMPLEMENTATION OF PARTICULAR PROVISIONS OF MUNICIPAL ORDINANCE NO. 2020-005 – MUNICIPAL TRAFFIC AND TRANSPORTATION CODE

WHEREAS, Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that the local government unit shall exercise the powers in the maintenance of peace and order, and the preservation of comfort and convenience of its inhabitants;

WHEREAS, Section 447 of the same Republic Act provides that the local government unit, subject to the guidelines prescribed by the Department of Transportation and Communications, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality;

WHEREAS, Municipal Ordinance No. 2020-005 otherwise known as the Municipal Traffic and Transportation Code provides for the policies concerning road safety and regulations for the proper utilization of roads and bridges;

WHEREAS, Municipal Executive Order No. 2020-016 designates the stretch of Luna Street fronting Gubat Yek Hua Trading towards GSAC is designated as the Delivery Area for Delivery Trucks only;

WHEREAS, with the implementation of the new traffic ordinance, other provisions were executed without problem except for the southern side of corner Luna and Manook Streets to corner Luna and Zulueta Streets where congestion problem exists;

WHEREAS, every time there is delivery in the designated delivery area, it requires movement and transfer of parking of tricycles to the other side of the street.;

WHEREAS, for ease of operation and maintenance of order in the area, there is a need to issue an executive order amending certain traffic guidelines;

NOW THEREFORE, I, SHARON ROSE G. ESCOTO, Municipal Mayor of Gubat, Sorsogon by virtue of the power vested in me by law, do hereby order the following:

SECTION 1. Tricycle Parking Area at Luna Street. Parking area for Public Motorized Tricycle for Hire shall be transferred to the northern side of Luna Street from corner Manook and Luna Streets to corner Zulueta and Luna Streets.


SECTION 2. Designated Delivery Area. The southern side of Luna from corner Manook and Luna Streets to corner Zulueta and Luna Streets shall be designated as the DELIVERY AREA for DELIVERY TRUCKS ONLY. Thus, all TODAs previously occupying this area will be transferred to the dedicated tricycle parking area across as stated in Section 1.

SECTION 3. Incorporation Clause. All laws, legal orders, rules and regulations that have been issued and/or will be issued by the duly constituted authorities of the Republic of the Philippines in relation to COVID-19 and the Modified General Community Quarantine (GCQ) are hereby incorporated herein and made an integral part hereof. In case of conflict, such laws, legal orders, rules and regulations shall have precedence over the provisions of this Executive Order.

SECTION 4. Repealing Clause. Any Executive Orders previously issued that are inconsistent to the provisions of this Executive Order is considered repealed, amended and modified accordingly.

SECTION 5. Effectivity. This order shall take effect immediately and shall remain valid and effective unless otherwise amended, repealed or modified accordingly.

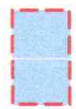




Delivery loading/ unloading
