EXECUTIVE ORDER NO. 2020 – 014

PROVIDING FURTHER GUIDELINES FOR THE LOCAL IMPLEMENTATION OF PARTICULAR PROVISIONS MUNICIPAL ORDINANCE NO. 2020-005 – MUNICIPAL TRAFFIC AND TRANSPORTATION CODE

WHEREAS, Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that the local government unit shall exercise the powers in the maintenance of peace and order, and the preservation of comfort and convenience of its inhabitants;

NOW THEREFORE, I, SHARON ROSE G. ESCOTO, Municipal Mayor of Gubat, Sorsogon by virtue of the power vested in me by law, do hereby order the following:

SECTION 1. Additional Parking Area. There shall be a designated parking area for Public Motorized Tricycle for Hire in addition to the parking area designated by the Municipal traffic and Transportation Code, to wit:

1. Southern portion of Herrera Street, from corner Manook and Herrera Streets to corner Zulueta and Herrera Streets;
2. Southern portion of Luna Street, from corner Quezon and Luna Streets to corner Burgos and Luna Streets

SECTION 2. Operation on coding system of Public Motorized Tricycle for Hire as stated in the Municipal Executive Order 2020-06 is now lifted. Each TODAs can establish their own system of scheduling operation to comply with LTFRB guidelines that only 50% of total number of tricycles can operate.

SECTION 3. Manook Street can be utilized by DELIVERY TRUCKS for DELIVERIES FROM 11:00 AM up to 3:00 PM ONLY.

SECTION 4 . Incorporation Clause. All laws, legal orders, rules and regulations that have been issued and/or will be issued by the duly constituted authorities of the Republic of the Philippines in relation to COVID-19 and the General Community Quarantine (GCQ) are hereby incorporated herein and made an integral part hereof. In case of conflict, such laws, legal orders, rules and regulations shall have precedence over the provisions of this Executive Order.

SECTION 5. Repealing Clause. Any Executive Orders previously issued that are inconsistent to the provisions of this Executive Order is considered repealed, amended and modified accordingly.

SECTION 6. Effectivity. This order shall take effect on 12:01 AM of April 27, 2021 and shall remain valid and effective unless otherwise amended, repealed or modified accordingly.
