The Local Government Unit of Gubat, through its 20% Municipal Development Fund 2022 intends to apply the sum of Seven Million-Eight Hundred Thousand Pesos (₱7,800,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Concreting/Reblocking of Padrique Street from Highway 59 to Fishlanding, Brgy. Manook-Brgy. Balud del Norte, Gubat, Sorsogon with identification no. PR 12834. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Local Government Unit of Gubat now invites bids for the above Procurement Project. Completion of the Works is required 125 calendar days.
