### **INVITATION TO BID FOR THE publication of municipal ordinance no. 2017-004 (an ordinance enacting the gender advocacy and development code of the municipality of gubat, and providing funds therefor and for other purposes [ 3 issues]**

1. The Local Government Unit of Gubat, through its General Fund intends to apply the sum of TWO MILLION PESOS(₱2,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for PR13372. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Local Government Unit of Gubat now invites bids for the **Publication Of Municipal Ordinance No. 2017-004 (An Ordinance Enacting The Gender Advocacy And Development Code Of The Municipality Of Gubat, And Providing Funds Therefor And For Other Purposes [ 3 issues]**. Delivery of the Goods is required within thirty (30) calendar days upon receipt of Notice to Proceed. Bidders should have completed, within the last two years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from Local Government Unit of Gubat and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm, Mondays to Fridays.
5. A complete set of Bidding Documents may be acquired by interested Bidders from April 11, 2022 to May 2, 2022 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php5000.00).
6. Bids must be duly received by the BAC Secretariat at the address below on or before 9:00 am on May 2, 2022. All Bids must be accompanied by a bid security in any of the

acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on 9:00 am on May 2, 2022 at the Municipal Conference Hall, Municipal Compound, Manook Street, Gubat Sorsogon. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
