INVITATION TO BID FOR PURCHASE OF MEDICINES FOR MUNICIPAL HEALTH OFFICE USE

1. The Local Government Unit of Gubat, through its General Fund intends to apply the sum of **Nine Hundred Sixty Thousand One Hundred Twenty-Three Pesos (P732,640.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **PR13591**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Local Government Unit of Gubat now invites bids for the **Purchase of Medicines for Municipal Health Office use**. Delivery of the Goods is required within 30 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183

4. Interested bidders may obtain further information from Local Government Unit of Gubat and inspect the Bidding Documents at the address given below, Monday to Friday from 8:00 am to 5:00 pm
5. A complete set of Bidding Documents may be acquired by interested bidders on June 3-10, 2022 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (P1,000.00).
6. Bids must be duly received by the BAC Secretariat at the address below on or before June 10, 2022, 8:00 am. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on June 10, 2022, 8:00 am, at Municipal Conference Room, Bldg. 1, Municipal Compound, Manook Street, Gubat, Sorsogon. The official time to be used is the Philippine Standard Time. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
