**CONTRACT FORM**

THIS AGREEMENT made this JUN 24 2022 between **THE LOCAL GOVERNMENT UNIT OF GUBAT** of the Philippines (hereinafter called "the Entity") of the one part and **DSM ENTERPRISES** (hereinafter called "the Supplier") of the other part:

Whereas the Entity invited Bids for certain goods, viz, the **PURCHASE OF COMMON BORROW FOR SITE DEVELOPMENT AT BALUD DEL NORTE, GUBAT, SORSOGON** with reference no. **PR13632** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SIX HUNDRED FIFTY-SIX THOUSAND SEVEN HUNDRED PESOS ONLY (P656,700.00)** herein after called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) Owner's Notification of Award
  - (b) Performance Security
  - (c) The Bid Form, and the Bills of Quantities with bid prices of the Supplier
  - (d) General and Special Conditions of the Contract
  - (e) Approved Resolution to Award
3. Completion period is required 30 calendar days and shall commence on the date of receipt of the Notice to Proceed by the Supplier, or on date specified in the Notice to Proceed if a date is specified for the purpose;
4. The amount of liquidated damages (LD) deductible from payments, due to Supplier, shall be one tenth of one percent (0.1%) of the cost of the unperformed portion of the Contract for every day of delay. Once the cumulative amount of LD reached 10% of the amount of this Contract, the owner shall rescind this contract without prejudice to the other courses of action and remedies open to it;
5. In consideration of the Contract Price mentioned herein to be paid by the Owner to the Supplier, the Supplier hereby covenants, with the Owner, to execute and complete such works and to remedy defects therein in conformity in all respect with the provisions of the Contract;
6. The owner hereby covenants to pay the Supplier in consideration of the execution and completion of such Works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract;
7. The Contract Price shall be paid to the Supplier through the Government disbursement procedure subject to the payment, retention money and warranty provisions in the General Conditions of the Contract, the Special Conditions of the Contract, and the IRR-A of R.A. 9184.


