The Local Government Unit of Gubat through its General Fund, intends to apply the sum of Seven Hundred Ninety Nine Thousand-Eight Hundred Fifty Pesos (\$\mathbb{P}\$799,850.00) being the Approved Budget for the contract (ABC) to payments under the contract for PR13551. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Local Government Unit of Gubat now invites sealed Bids from Eligible Bidders for the Purchase of medicines for Municipal Health Office use. Delivery of the Goods is required within 30 calendar days.

Bidding will be conducted in accordance with relevance procedures for Open Competitive Biddingas specified in the Implementing Rules and Regulations Part A (IRR-A) of REPUBLIC Act No. 9184 (R.A 9184), otherwise known as the Government Procurement Reform Act., and is restricted to organizations with at least sixty percent (60%) of outstanding capital stock belonging to citizens of the Philippines, as specified in Republic Act 5183 (R.A 5183). Only Bids from Bidders who pass the Eligibility check will be opened. The Bidder with the Lowest Calculated Bid (LCB) shall advance to the post qualification stage in order to finally determine his responsiveness to the technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated Bidder (LCRB) who was determined as such during the post- qualification procedure.
