

CONTRACT FORM

THIS AGREEMENT made this 30th day of August, 2022 between **THE LOCAL GOVERNMENT UNIT OF GUBAT** of the Philippines (hereinafter called "the Entity") of the one part and **LINGSNET COMMERCIAL CORPORATION** (hereinafter called "the Supplier") of the other part:

Whereas the Entity invited Bids for certain goods, viz., **Purchase of additional 30 units tablets to be used for the Community Based Monitoring System 2022 Roll-out, with reference no. PR13519** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **THREE HUNDRED FORTY FIVE THOUSAND PESOS (P345,000.00)** hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
