





THIS AGREEMENT made this DEC 16 2022 between **THE LOCAL GOVERNMENT UNIT OF GUBAT** of the Philippines (hereinafter called "the Entity") of the one part and **ROLANDO E. EMBILE** (hereinafter called "the Supplier") of the other part:

Whereas the Entity invited Bids for certain goods, viz, the **PURCHASE OF 24 SACKS OF BROWN RICE with reference no. PR342** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SEVENTY TWO THOUSAND PESOS** herein after called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - 2.1. Owner's Notification of Award
 - 2.2. The Bid Form of the Supplier
 - 2.3. Approved Resolution to Award
3. Completion period is required 7 calendar days and shall commence on the date of receipt of the Notice to Proceed by the Supplier, or on date specified in the Notice to Proceed if a date is specified for the purpose;
4. The amount of liquidated damages (LD) deductible from payments, due to Supplier, shall be one tenth of one percent (0.1%) of the cost of the unperformed portion of the Contract for every day of delay. Once the cumulative amount of LD reached 10% of the amount of this Contract, the owner shall rescind this contract without prejudice to the other courses of action and remedies open to it;
5. In consideration of the Contract Price mentioned herein to be paid by the Owner to the Supplier, the Supplier hereby covenants, with the Owner, to execute and complete such works and to remedy defects therein in conformity in all respect with the provisions of the Contract;
