

CONTRACT FORM

THIS AGREEMENT made this 23rd day of December, 2022 between **THE LOCAL GOVERNMENT UNIT OF GUBAT** of the Philippines (hereinafter called "the Entity") of the one part and **GDBS BUILDERS AND ENTERPRISE** (hereinafter called "the Supplier") of the other part:

Whereas the Entity invited Bids for certain goods, viz., **CLUSTERED PROJECTS: CONSTRUCTION OF RIPRAP/RIVER CONTROL PROTECTION, SITIO BIAO, BRGY. CARRIEDO, GUBAT, SORSOGON; 2. CONSTRUCTION OF RIPRAP/SLOPE PROTECTION, BRGY. NAZARENO, GUBAT, SORSOGON with reference no. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


