



EXECUTIVE ORDER NO. 4
Series of 2023

AN ORDER MANDATING THE ACTIVE IMPLEMENTATION AND SPACE MONITORING OF THE DRUG-CLEARING PROGRAM IN THE MUNICIPALITY OF GUBAT

WHEREAS, DILG Memorandum Circular NO. 2015-63 or the “Revitalization of the Barangay Drug Abuse (BADAC) and their Role in Drug Clearing Operations” reinforces the mandate of the barangay to adopt measures towards the prevention and eradication of drug abuse, etc. (Section 31 of the LGC of 1991);

WHEREAS, in order to actively and effectively implement and monitor the “Anti-Drug Program” in the municipality it is necessary that the different barangays and agencies in the LGU work collaboratively and come up with strategies or schemes for the eradication of the drug menace;

WHEREAS, the LGU directs the conduct of varied interventions which can be in the form of symposium, sports fest, tree-planting, clean-up drive activities, skills development training, livelihood and assistance and the like in order to increase public awareness on the medical ill-effects of dangerous drug, the provisions of RA 9165 and programs offered by the LGU for this particular program;

WHEREAS, the Balay-Silangan should be made operational/functional in order to make the attendees more productive, totally reformed and acceptable to society and be able in turn to give their rightful contribution for a drug-free municipality.

NOW, THEREFORE, I RONNEL U. LIM, Municipal Mayor of Gubat, Sorsogon by virtue of the powers vested in me by the law do hereby order the following:

Section 1. Composition of the MADAC CORE TEAM. The MADAC CORE TEAM is composed of PNP, MSWDO, MHO, and BADAC.

Section 2. Functions, Duties and Responsibilities. The MADAC CORE TEAM is tasked with the following:

- a. Orientation/advocacy activities to 42 barangays in the municipality;
- b. Conduct mandatory physical examination, laboratory and other ancillary test and referral for proper/appropriate intervention;
- c. Provide recovery and wellness programs to Persons Who Use Illicit Drugs (PWUDs):
 - Clinical services/medical services to PWUDs with comorbidities.
 - Counseling services at least 24 counseling sessions for (6) months.
 - Monthly assessment of client’s progress.
 - Conducts of unannounced random drug test.
 - Provision of Psycho-Social services/values and spiritual formation.

- Provide access to sustainability programs-like skills development training, livelihood education and assistance and educational support to PWUDs needing such assistance.

Section 3. Automatic Succession of Members. In case of resignation, retirement, separation, transfer, reassignment, removal of a member, the successor or replacement shall automatically take the position and serve only for the unexpired term. Provided that in case of leave or suspension, the replacement shall serve only for the duration of the leave or suspension.

Section 4. Separability Clause. In the event that any provision of this Executive Order is held invalid or unconstitutional, the provisions not affected thereby shall remain in full force and effect.

Section 5. Effectivity. This Executive Order shall take effect immediately.
