EXECUTIVE ORDER NO. 7

RECONSTITUTING THE RETOOLED COMMUNITY SUPPORT PROGRAM (RCSP) TEAM AND THE CORE TEAM OF THE MUNICIPALITY OF GUBAT SORSOGON, IDENTFYING ITS MEMBERS, THEIR DUTIES AND FUNCTIONS AND FOR OTHER PURPOSES

WHEREAS, President Rodrigo Roa Duterte issued the Executive Order No. 70 last 04 December 2018, entitled "Institutionalizing the Whole-of-Nation approach in attaining inclusive and sustainable peace, creating a National Task Force to end Local Communist Armed Conflict, and directing the adoption of a National Peace Framework".

WHEREAS, EO 70 stipulated the need to reframe and refocus government policies in order to achieve inclusive and sustainable peace by recognizing local armed conflicts are not only a military concern but also symptomatic of a broader social, economic and governance challenges manifested by prevalence of poverty, lack or better in chances, historical injustice, social inequalities and exclusivity:

WHEREAS, the Retooled Community Support Program (RCSP) was formulated in order to operationalized the said "Whole-of-Nation Approach" by strengthening the Community Support Program (CSP) initiatives of the military and making the effort Local Government Units (LGU) driven;

WHEREAS, the Local Chief Executives (LCEs) shall be the champion of the RCSP implementation through their programs, projects, and activities (PPAs) that are geared towards institutionalizing sustainable peace and development;

WHEREAS, the RCSP is an inclusive program that aims to address identified issues of the community by closing the governance and development gaps through provision of needed government PPAs while ensuring that development is sustained and peace is being promoted;

WHEREAS, RCSP Teams shall be created at the provincial, city, and municipal level to spearhead the operationalization of the RCSP; WHEREAS, the Municipal Core Team shall also be created to serve as the unit that directly provides all necessary tactical, technical, logistical, and administrative support to the LCE in the performance of its function as the RCSP Head;

NOW THEREFORE, I, RONNEL U. LIM, Municipal Mayor of Gubat, Sorsogon, by virtue of the powers vested in me by law, do hereby order the organization of the RCSP Team and the Core Team of the Municipality of Gubat, Sorsogon:

RETOOLED COMMUNITY SUPPORT PROGRAM (RCSP) TEAM

SECTION 1. COMPOSITION. The RCSP Team and Core Team shall be composed of the following:

1. The RCSP Team

Head of the RCSP Team: RONNEL U. LIM, Municipal Mayor

SECTION 2. The RCSP Team and Core Team shall perform the following functions:

SECTION 2.1 The Head of the RCSP Team. The Municipal Mayor, being the Head of the RCSP Team, shall perform the following functions:

- 1. Champion the cause to be at the forefront of the stride of bringing the needed government interventions to the people through RCSP.
- 2. In-charge with the deployment of the RCSP Team to the target barangay for immersion, and
- 3. Ensure that development initiatives are properly delivered, immediate needs properly addressed, and that long-term needs are properly programmed for funding and implementation.

SECTION 2.2 Basic Service Delivery Team (BSDT) The BDST is the team tasked to serve as the primary bridge of the RCSP Team to the national government.

SECTION 2.3 Citizenship and Community Participation Team (CCPT) The CCPT shall perform the following:

- 1.Organize the Citizenship Movement by mobilizing communities into sectoral groups.
- 2.Encourage the communities to participate in all sectoral dialogues/solution-seeking tables aimed to validate the governance and development gaps of the communities and identify the needed government interventions to address them.

SECTION 2.4 Peace, Law Enforcement and Development Support (PLEDS) Team, The PLEDS Team shall perform the following:

- 1. Conduct clearing operations one week prior to the actual send-off of the RCSP Team,
- 2. Ensure perimeter security of the target-barangays during the entire duration of the immersion, and
- 3. Continuous sanitation of the community form terrorist threats during the implementation and provision of the needed government interventions.

SECTION 2.5 RCSP Core Team, The RCSP Core team shall serve as the unit that directly provides all necessary tactical, logistical, and administrative assistance to the LCE in the performance of its functions as the RCSP Head.

SECTION 3. LINKAGES. The Municipal Development Council (MDC) and Municipal Peace and Order Council (MPOC) shall maintain a vital linkage to the RCSP Team for the purpose of programs and projects coordination. The Councils shall focus on screening and prioritizing needed government interventions that must be included as priority in the Local Development Investment Program (LDIP). Furthermore, the RCSP Team must also ensure that identified PPAs shall be implemented by securing available funding under all available sources from both national and local government resources.

SECTION 4. FUNDING. The funds needed for the operation of Teams are chargeable against the LGU fund and National Government Agencies, specifically the appropriated amount for the implementation of EO 70.

- 1. Department of Agriculture (DA)
- 2. Department of Agrarian Reform (DAR)
- 3. Department of Environment and Natural Resources (DENR)
- 4. Department of Public Works and Highways (DPWH)
- 5. Department of Health (DOH)
- 6. Department of Education (DepEd)
- 7. Commission on Higher Education (CHED)
- 8. Technical Education and Skills Development Agency (TESDA)
- 9. Department of Social Welfare and Development (DSWD)
- 10. National Commission on Indigenous Peoples (NCIP) where relevant
- 11. Include also herewith as an optional representative is the Regional ELCAC Technical Working Group (TWG) from needed Lines of Effort (LOE).
- 12. Other agencies that may be identified in responding
- 13. The configuration and membership of the BSDT shall be determined by the
- 14. RSCP Core Team configuration and shall depend upon the issues identified by the community during the profiling and/or based on the results of Social Investigation Class Analysis (SICA), data from Community-Based Monitoring System (CBMS), Governance Assessment Report (GAR), Geographically Isolated and Disadvantages Areas (GIDAS), Information from previous CSP immersion among other.

- 1. Municipal Planning and Development Coordinator (MPDC)
- 2. Punong Barangay of the Target Barangay
- 3. Members of the Sangguniang Barangay of the target-barangay
- 4. Principal/Head Teacher in the public school located in the concerned barangay
- 5. Sangguniang Kabataan Chairperson of the target-barangay
- 6. A Lupong Tagapamayapa of the target-barangay
- 7. Designated member from the RCSP Core Team
- 8. Representative from the Barangay Public Safety Officers of the targetbarangay
- 9. Representative from the local CSO or PO of the target-barangay.
- 10. Congressional Representative or designated staff
- 11. Representative from an inter-faith group
- 12. Representative from the private Sector
- 13. Media

C. Peace, Law Enforcement & Development Support (PLEDS) Team

- 1. Representative from AFP through its nine (9) man CSP Team
- 2. Two (2) uniformed personnel each from the Philippine National Police (PNP) and Sorsogon 1 st Provincial Mobile Force Company, and the Bureau of Fire Protection (BFP) to assist in the clearing operations, gathering of information, perimeter security and first-aid in case of emergency.
- 3. If any, Former rebel (cadre level) available in the area as additional Manpower and information support.
