AN EXECUTIVE ORDER REORGANIZING LUPONG TAGAPAMAYAPA MUNICIPAL AWARDS COMMITTEE (MAC) FOR 2023 LUPONG TAGAPAMAYAPA INCENTIVES AWARDS (LTIA) ASSESSMENT IN THE MUNICIPALITY OF GUBAT, SORSOGON

WHEREAS, Executive Order No. 394 series of 1997 provides for the establishment of the Lupong Tagapamayapa Incentives Awards (LTIA) as an Annual National Awards to strengthen the Katarungang Pambarangay as indigenous conflict resolution structures at the grassroots, institutionalize a system of granting economic benefits and other incentives to Lupon which demonstrate exemplary performance, and generated greater awareness among and support from the various sectors of Philippine society as a potent vehicle toward social ordering and human development;

WHEREAS, Section 3 of same executive order provides for the Creation of Lupong Tagapamayapa Awards Committee;

WHEREAS, DILG Memorandum Circular No. 2023-022 dated February 8, 2023, provides for the composition and functions of LTIA Municipal Awards Committee;

NOW THEREFORE, I RONNEL U. LIM, Municipal Mayor of Gubat, Sorsogon, by virtue of powers vested in me by law, do hereby order:

Section 1. Creation and Constitution of Municipal Awards Committee. It is hereby created the Lupong Tagapamayapa Municipal Awards Committee (MAC) at the Municipality of Gubat, Sorsogon. The Municipal Awards Committee shall be composed of:

Section 2. Functions. The Lupong Tagapamayapa Municipal Awards Committee shall perform the following functions;

1. Initiate and coordinate the necessary activities toward the successful implementation of the LTIA in their level;
2. Disseminate information on the Awards to generate awareness and support from the public and private sectors within the municipality;
3. Select and submit to the Provincial Awards Committee (PAC) the best performing Lupons within the municipality;
4. May secure funding and counterpart prizes from the partner agencies and the private sector; and
5. May plan and implement appropriate awarding ceremonies.

Section 3. Secretariat. The DILG Municipal Office will provide technical and secretariat services to the committee.

Section 4. Automatic Succession of Members. In case of resignation, retirement, separation, transfer, re-assignment, removal of member, the successor or replacement shall automatically take the position and serve only for the unexpired term. Provided, that in case of leave or suspension, the replacement shall serve only for the duration of the leave or suspension.

Section 5. Repealing Clause. All prior issuances and orders inconsistent with this Executive Order are hereby repealed.

Section 6. Separability Clause. In the event that any provision of this Executive Order is held invalid or unconstitutional, the provisions not affected thereby shall remain in full force and effect.

Section 7. Effectivity. This Executive Order shall take effect immediately.
