



EXECUTIVE ORDER NO. 13

**CREATION OF THE LOCAL MARKET COMMITTEE (LMC) OF THE
MUNICIPALITY OF GUBAT AND DEFINING ITS POWERS AND FUNCTIONS**

WHEREAS, Section 10, Article K of SB Resolution No. 132 s-2004, otherwise known as the 2005 Revenue Code of the Municipality of Gubat, Sorsogon, provides for the creation of the Local Market Committee which shall implement the approved market ordinances;

WHEREAS, the Gubat Public Market is one of the viable economic enterprises of the municipality established for its self-reliance and viability, equipped with facilities for the services of the buying product;

WHEREAS, for the attainment of the objectives enunciated in the Market Ordinance, there is a need to create a body that shall implement, continue and better and better the delivery of services by the Municipality to its constituents through the Gubat Public Market;

NOW THEREFORE, I RONNEL U. LIM, Municipal Mayor of the Municipality of Gubat, Province of Sorsogon, by virtue of the power vested in me by law, do hereby order the creation of the Local Market Committee of this municipality;

SECTION 1. COMPOSITION. The Local Market Committee shall be composed of the following:

SECTION 2. POWERS AND FUNCTIONS. The power and functions of Local Market Committee are the following:

1. Conduct the drawing of lots and opening of bids in connection with the adjudication of vacant or newly constructed stalls or booth in the public

- market, supermarket building or any municipal lots, for such purpose and to certify to the Municipal Mayor the results thereof;
2. Formulate policies, rules and regulations for market operations and administration;
 3. Conduct periodic review of public market operation;
 4. Impose sanctions and penalties of violators in accordance with the ordinance;
 5. Hear and settle grievances arising out of market operations and administration.

SECTION 3. MEETINGS. The Local Market Committee shall have its regular meeting every quarter, however the Chairman may call a special meeting anytime for the purpose of taking up specific matters.

SECTION 4. AUTOMATIC SUCCESSION OF MEMBERS. In case of resignation, retirement, separation, transfer, re-assignment, removal of member, the successor or replacement shall automatically take the position and serve only for the unexpired term. Provided, that in case of leave or suspension, the replacement shall serve only for the duration of the leave or suspension.

SECTION 5. REPEALING CLAUSE. All prior issuance and orders inconsistent with this Executive Order are hereby repealed.

SECTION 6. SEPARABILITY CLAUSE. In the event that any provision of this Executive Order is held invalid or unconstitutional, the provisions not affected thereby shall remain in full force and effect.

SECTION 7. EFFECTIVITY. This Executive Order shall take effect immediately.
