AN ORDER CREATING THE TECHNICAL WORKING GROUP FOR THE FORMULATION OF THE LOCAL SHELTER PLAN

WHEREAS, Section 17 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that local government units shall exercise powers, functions, and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of basic services and facilities which include low-cost housing and other mass dwellings;

WHEREAS, DILG Memorandum Circular No. 2008-143 mandates local government units to create Local Housing Boards;

WHEREAS, Republic Act 7279, also known as the "Urban Development and Housing Act of 1992", mandates local government units to formulate a comprehensive plan for urban development, taking into consideration the existing land use plans, housing programs, and all other projects and activities of government agencies and private sector which may substantially affect land use patterns, transportation and public utilities, infrastructure, environment, and population movements;

WHEREAS, natural disaster, insurgency, relocation projects, demolitions, and other similar events may left households homeless and displace;

WHEREAS, there is a need to provide relocation projects, demolitions, and other similar events may left households homeless and displaced;

WHEREAS, there is a need to provide relocation and resettlement of persons living in danger areas such as riverbanks, waterways, among others and provide relocation and resettlement sites and basic services and facilities, access to employment and livelihood opportunities sufficient to meet the basic needs of the affected families:

WHEREAS, the Municipal Government of Gubat recognizes the need for a long-term comprehensive housing plan being an integral part of its responsibility in providing basic services and socio-economic development to its constituents;

WHEREAS, to ensure effective and proper implementation of its mandate, it is necessary to create and mobilize the Technical Working Group who will formulate the Local Shelter Plan of the municipality;

NOW THEREFORE, I, RONNEL U. LIM, Municipal Mayor of the Municipality of Gubat, Province of Sorsogon, by virtue of the power vested in me by law, do hereby order the creation and mobilization of the Technical Working Group (TWG) which shall be composed of the following:

Section 2. **Duties and Functions.** The TWG shall be responsible of the following:

- 1. Gather available data process information relevant to the preparation of the LSP;
- 2. Ensure policy coordination and uniformity in operational directions for shelter planning;
- 3. See to it that the processing of information and the corresponding actions are in line with national and local policies and standards;
- 4. Establish (or maintain) linkages with and seek substantial inputs from the appropriate national government agencies, civil society organizations, and private sector groups in all stages of the local shelter planning and development processes; and,
- 5. Formulate the LSP and initiate community validation and consultation.

Section 3. Automatic Succession of Members. In case of resignation, retirement, separation, transfer, re-assignment, removal of member, the successor or replacement shall automatically take the position and serve only for the unexpired term. Provided, that in case of leave or suspension, the replacement shall serve only for the duration of the leave or suspension.

Section 4. Repealing Clause. All prior issuance and orders inconsistent with this Executive Order are hereby repealed.

Section 5. Separability Clause. In the event that any provision of this Executive Order is held invalid or unconstitutional, the provisions not affected thereby shall remain in full force and effect.

Section 6. Effectivity. This Executive Order shall take effect immediately.
