## FURTHER RECONSTITUTING THE MUNICIPAL DEVELOPMENT COUNCIL OF THE MUNICIPALITY OF GUBAT, IDENTIFYING ITS MEMBERS, THEIR DUTIES AND FUNCTIONS AND OTHER PURPOSES

**WHEREAS,** Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides for the creation of a municipal development council (MDC) in municipalities;

**WHEREAS**, the said Code provides that each municipality shall have a multisectoral development plan to be initiated by its MDC and approved by its Sangguniang Bayan;

**WHEREAS**, Section 444 (2) (iii) of the said Code states that the local chief executive shall issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances;

**WHEREAS**, the MDC shall assist the Sangguniang Bayan in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction.

**WHEREAS**, the recent local election requires reconstitution of the MDC due to the end of term of office of former MDC members; and

**WHEREAS**, The Municipal Government would like to ensure the seamless transition to the new administration including the continuity of the functions and programs of the MDC;

**NOW, THEREFORE, I, RONNEL U. LIM** Municipal Mayor of Gubat, Province of Sorsogon, by virtue of the powers vested in me by the law, do hereby order the following:

**Section 1. Composition**. The MDC is hereby reconstituted to be composed of the following:

# **Section 2. Duties and Functions of the MDC.** The MDC shall perform the following functions:

- (1) Formulate long term, medium term, and annual socioeconomic development plans and policies;
- (2) Formulate the medium-term and annual public investment programs;
- Appraise and prioritize socioeconomic development programs and development;
- (4) Formulate local investment incentives to promote the inflow and direction of private investment capital;
- (5) Coordinate, monitor, and evaluate the implementation of development programs and projects; and
- (6) Perform such other functions as may be provided by law or competent authority

**Section 3. Executive Committee.** The Executive Committee of the MDC is hereby created to represent it and act on its behalf when it is not session. The composition of the executive committee shall be a follows:

**Section 4. Duties and functions of the MDC Executive Committee.** The MDC Executive Committee shall perform the following functions:

- a). Ensure that the decisions of the council are faithfully carried out and implemented
- **b).** Act on matters requiring immediate attention or action by the Council;
- c). Formulates policies, plans and programs based on the general principles laid down by the Council; and
- d). Act on other matters that may be authorized by the Council.

**Section 5. Secretariat.** The Secretariat shall be responsible for providing technical support, documentation of proceedings; preparation of reports and such other assistance as may be required in the discharge of its functions. The Secretariat function shall be performed by the Municipal Planning and Development Coordinator.

## Section 6. Meeting and Quorum

a) The MDC shall meet at least once every six (6) months or as often as may be necessary as determined by the chairperson.
b) A majority of the members of the council shall constitute a quorum. The affirmative vote of a majority of the members shall be necessary to approve plans, policies, and program and project proposals.

**Section 7. Automatic Succession of Members.** In case of resignation, retirement, separation, transfer, reassignment, removal of a member, the successor or replacement shall automatically take the position and serve only for the unexpired term. Provided that in case of leave or suspension, the replacement shall serve only for the duration of the leave or suspension.

**Section 8. Compensation and Remuneration.** The chairperson and members of the MDC shall perform their duties as such without compensation or remuneration. Members thereof who are not government officials or employees shall be entitled to necessary traveling expenses shall allowances chargeable against the fund of the MDC, subject to existing accounting and auditing rules and regulations.

**Section 9. Technical Assistance to the Council.** All Municipal Government Offices/Department/Agencies are hereby enjoined to provide technical assistance, support, and cooperation to the Council.

**Section 10. Repealing Clause.** Any administrative or Executive Order previously issued that are inconsistent with the provisions of this Executive Order shall be considered repealed, amended or modified accordingly.

**Section 11. Separability Clause.** In the event that any provision of this Executive Order is held invalid or unconstitutional, the provisions not affected thereby shall remain in full force and effect.

Section 12. Effectivity. This Executive Order shall take effect immediately.
