RECONSTITUTING AND STRENGTHENING THE MUNICIPAL GENDER AND DEVELOPMENT FOCAL POINT SYSTEM (GADFPS) AND CREATING ITS EXECUTIVE COMMITTEE AND SECRETARIAT/TECHNICAL WORKING GROUP

WHEREAS, Section 14 of Article II of the Constitution provides that the state recognizes the role of women in nation-building and shall ensure the fundamental equality before the law of women and men;

WHEREAS, Republic Act No. 7192, otherwise known as the "Women in Development and Nation-building, and shall ensure the fundamental equality before the law of women and men;

WHEREAS, in order to ensure the implementation of the mandated tasks to the LGU, the re-organization and strengthening of MUNICIPAL GENDER AND DEVELOPMENT FOCAL POINT SYSTEM as institutional mechanism will facilitate the sustainability of the implementation of its provisions;

WHEREAS, there is a need to reorganize and strengthen this committee following the new set of local officials and re-assignment of some representatives from the national government stationed in this municipality;

Section 5. MEETINGS. The council shall meet quarterly to address the important issues and concerns of the sector and prepare reports to the next higher GAD council.

Section 6. AUTOMATIC SUCCESSION OF MEMBERS. In case of resignation, retirement, separation, transfer, re-assignment, removal of a member, the successor or replacement shall automatically take the position and serve only for the unexpired term. Provided, that in case of leave or suspension, the replacement shall serve only for the duration of the leave or suspension.

Section 7. REPEALING CLAUSE. All orders and issuances which are inconsistent with this order are hereby repealed or modified accordingly.

Section 6. EFFECTIVITY. This order shall take effect immediately upon approval.
