**EXECUTIVE ORDER NO. 21**

**EXPANDING THE MEMBERSHIP OF THE MUNICIPAL DISASTER RISK REDUCTION  
MANAGEMENT COUNCIL (MDRRMC) RELATIVE TO THE IMPLEMENTATION OF THE  
KALAH-CIDSS NCDDP ADDITIONAL FINANCING FOR COVID-19 RESPONSE AND  
RECOVERY IN THE MUNICIPALITY OF GUBAT**

**WHEREAS**, Section 11 of the Republic Act 10121 otherwise known as "The Philippine Disaster Risk Reduction and Management Act 2010" mandates the organization at the local level of Local Disaster Risk Reduction and management Councils (LDRRMC) to replace existing Local Disaster Coordinating Councils (LDCC):

**WHEREAS**, the issuance of Presidential Proclamation No. 922, series of 2020, declares the entire country under the state of public health emergency due to the pandemic, such that all government agencies and LGUs are enjoined to render full assistance and cooperation, and mobilize the necessary resources to undertake critical, urgent and appropriate measures in a timely manner to curtail and eliminate the underlying threats of COVID-19;

**WHEREAS**, the Kapit-Bisig Laban sa Kahirapan Comprehensive and Integrated Delivery of Social Services National Community-Driven Development Program (KALAH-CIDSS NCDDP) is one of the property alleviation programs of the Philippine government being implemented by the Department of Social Welfare and Development (DSWD). Its capacity to work on the people in the vulnerable community will be taking its experience to use the program to complement with all other efforts of different government agencies;

**WHEREAS**, the Municipality of Gubat is one of the thirty-three (33) municipalities eligible for the KALAH-CIDSS NCDDP Additional Financing of the DSWD;

**WHEREAS**, the DSWD KALAHI\_CIDSS NCDDP has shifted its focus from the regular Community Empowerment Activity Cycle (CEAC) to Disaster Response Operation Modality/Procedure (DROM/P) focusing on the COVID-19 response and recovery among the poor and marginalized and capacitating communities to protect themselves from the effects of plausible similar disasters in the municipality;

**WHEREAS**, the expansion of the existing MDRRMC is necessary to strengthen people's participation relative to the implementation of the KALAHI-CIDSS-NCDDP AF for COVID-19 response and recovery;

**NOW THEREFORE I, RONNEL U. LIM**, Municipal Mayor of the Municipality of Gubat, Province of Sorsogon, by virtue of the powers vested in me by law, do hereby order the expansion of the membership of the Municipal Disaster Risk Reduction Management Council (MDRRMC) relative to the implementation of the KALAHI-CIDSS NCDDP Additional Financing for COVID-19 response and recovery in the Municipality of Gubat, to wit;

**SECTION 1, Additional members of the MDRRMC.** In the implementation of the KALAHI-CIDSS NCDDP Additional Financing, the expanded MDRRMC shall include the following additional members:

MS. ROCHELLE E. LADIP	-Community Volunteer
MR. ANTHONY LORENZO II	-Community Volunteer
MS. REGIN ESPALDON	-Community Volunteer
MS. ANNA MELISA CIPCON	-Area Coordinator, KALAHI

**SECTION 2. Functions and responsibilities.** In addition to the functions and responsibilities of the regular MDRRMC provided for by law, the expanded MDRRMC relative to the implementation of the KALAHI-CIDSS NCDDP Additional Financing for COVID-19 response and recovery shall have the following functions:

- Serve as the main local special body that will provide technical assistance in all the stages of implementation of the KALAHI-CIDSS NCDDP Additional Financing for COVID-19 in the municipality.
- Serve as the approving body of the criteria for the KALAHI-CIDSS NCDDP Additional Financing grant allocation per barangay.
- Serve as the primary venue for the planning, discussion, deliberation and approval of the proposed BDRRMC COVID-19 projects, program and interventions to be funded by the KALAHI grant under the KALAHI-CIDSS NCDDP Additional Financing for COVID-19 in lieu of the Municipal Inter Barangay Forum in the regular CEAC process.

**SECTION 3. Effectivity.** This executive order shall take effect immediately and shall remain enforced until rescinded, modified or supplemented.
