



EXECUTIVE ORDER NO. 25

**RECONSTITUTING THE LOCAL COMMITTEE ON ANTI-TRAFFICKING AND
ANTI-VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCAT- VAWC) OF
THE MUNICIPALITY OF GUBAT, SORSOGON**

WHEREAS, Republic Act No. 7610, otherwise known as the “Special Protection of children Against Child Abuse, Exploitation and Discrimination”, remains as the principal and comprehensive law for the protection of children against abuse and exploitation;

WHEREAS, RA 9262 underscore the commitment of the state on safeguarding the dignity women and children while guaranteeing full respect of their human rights and to protect them from violence and threats to their personal safety and security:

WHEREAS, Executive Order No. 53 dated August 11, 2011 ordering the strengthening of the committee for the special protection of children, amending for this purpose Executive Order No. 275 (s. 1995);

WHEREAS, DILG-DSWD-DOJ Joint Memorandum Circular No. 2010-1 dated October 18, 2010 re Creation of Local Committees on Anti-Trafficking and Anti-Violence Against Women and their Children (LCAT-VAWC);

NOW THEREFORE I, RONNEL U. LIM, Municipal Mayor of the Municipality of Gubat, Province of Sorsogon, by virtue of the power vested in me by law, do hereby order the reconstitution of the Local Committee on Anti-Trafficking and Anti-Violence Against Women and Their Children (LCAT-VAWC);

SECTION 1. COMPOSITION. The Local Committee on Anti-Trafficking and Anti-Violence Against Women and Their Children (LCAT-VAWC) shall be composed of the following:

SECTION 2. DUTIES AND FUNCTIONS. The LCAT-VAWC shall have the following duties and functions:

1. Formulate LCAT-VAWC Action Plan;
2. Institute policies and programs to protect women and children who are victims of trafficking and violence, and recommend to Sangguniang the passage of resolutions/ordinances thereto;
3. Create and establish system of surveillance investigation and rescue to ensure effective and efficient coordination;
4. Undertake information education and advocacy campaign against trafficking in persons and VAWC;
5. Monitor and oversee the strict implementation of RA 9208, RA 9262, and other related laws for the protection of women and children, and the of the LCAT-A-VAWC national plan of action;
6. Implement the programs, projects and activities in the national action plan.

SECTION 3. TECHNICAL WORKING GROUP/ SECRETARIAT. There shall be a technical working group or secretariat led by the MSWDO. They shall be responsible for providing technical support, documentation of proceedings, preparation of reports and other assistance as may be required in the discharge of its functions.

SECTION 4. MEETINGS. The Committee shall meet at least once per semester to address the important issues and concerns of the sector.

SECTION 5. SEPARABILITY CLAUSE. In the event that any provision of this Executive Order is held invalid or unconstitutional, the provisions not affected thereby shall remain in full force and effect.

SECTION 7. EFFECTIVITY. This executive order shall take effect immediately.
