## **EXECUTIVE ORDER NO. 27**

Series of 2022

## PROVIDING FOR THE CREATION OF THE SOCIAL PROTECTION TEAM (SP TEAM) FOR THE MUNICIPALITY OF GUBAT, DEFINING ITS DUTIES AND FUNCTIONS AND APPROPRIATING FUNDS THEREFOR

**WHEREAS,** the 1987 Philippine Constitution declares that the maintenance of peace and order, the protection of life, liberty and property and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy:

**WHEREAS,** Republic Act 7160, otherwise known as the Local Government Code 1991, mandates the Local Government Units (LGUS) to provide social welfare services to its constituents which include programs and projects;

**WHEREAS,** Section 7 of Executive Order No.43, series of 2011, provides that Human Development and Poverty Reduction cluster as part of the organized Cabinet clusters shall pursue the goal of increasing social protection and engaging communities in their own development:

**WHEREAS,** Chapter 8 of the Philippine Development Plan (PDP 2017-2022- Social Development considered social protection as one of the strategies to achieve the goal, of reducing poverty and promoting inclusive growth and equitable access to quality-basic social services, especially by the poor and vulnerable. It highlights the role of Social Protection in reducing people's vulnerability to various types of risks.

**WHEREAS,** Social Protection as defined in NEDA - Social Development Committee (SDC through Resolution No. 1, series of 2007, "constitutes policies and programs that seek to reduce poverty and vulnerability to risks and enhance the social status and rights of the marginalized by promoting and protecting livelihood and employment, protecting against hazards and sudden loss of income, and improving people's capacity to manage risks.

**WHEREAS,** a Sub-Committee on Social Protection (SCSP) under the SDC NEDA - Social Development Committee (SDC was created through SDC Resolution No.2, series of 2009 to lead in the formulation and operationalization of medium-term social protection plan and other social protection policies and strategies. This also paved the way for the development of the Social Protection Operational Framework and Strategy.

**WHEREAS**, Municipal Government aims to institutionalize the provision of immediate and long-term assistance that will mainstream the Social Protection in the Municipality of Gubat.

**NOW THEREFORE, I RONNEL U. LIM**, Municipal Mayor of Gubat, Sorsogon, by virtue of the power vested on me by law, do hereby create the SOCIAL PROTECTION TEAM (SP Team) for the Municipality of Gubat, defining its duties and functions and appropriating funds therefor.

**SECTION 1. COMPOSITION**. The Social Protection Team shall be composed of the following:

**SECTION 2. DUTIES AND FUNCTIONS.** The Social Protection Team shall have the following duties and functions:

- 1. Ensure the convergent effort in the delivery of the identified services of the program;
- 2 Identify key present issues related to social protection;
- 3. Formulate policies related to social protection;
- 4. Make an inventory of Social Protection related local policies and programs;
- 5. Develop outcomes, outputs and indicators for Local Social Plan.

**SECTION 3. AUTOMATIC SUCCESSION OF MEMBERS**. In case of resignation, retirement, separation, transfer, re-assignment, removal of a member, the successor of replacement shall automatically take the position and serve only for the unexpired

term Provided, that in case of leave or suspension, the replacement shall serve only for the duration of the leave or suspension.

**SECTION 4. REPEALING CLAUSE**. All issuances, memoranda and special orders issued inconsistent herewith are hereby superseded, repealed and amended accordingly.

**SECTION 5. SEPARABILITY CLAUSE.** If any provision of this resolution found to be unconstitutional or inconsistent with any national or local laws, ordinances or resolutions, all the other provisions thereof shall remain in full force and applicable.

SECTION 6. EFFECTIVITY. This order shall take effect immediately.
