



**EXECUTIVE ORDER NO. 15**

*Series of 2023*

**AN ORDER RECONSTITUTING THE MUNICIPAL NUTRITION COMMITTEE (MNC) AND CREATING ITS TECHNICAL WORKING GROUP/SECRETARIAT OF THIS MUNICIPALITY**

**WHEREAS**, Section 16 and 17 of Republic Act 7160 otherwise known as the Local Government Code of 1991, mandates Local Government Unit to ensure general welfare and provision of basic services;

**WHEREAS**, the Local Government Code of 1991 provides for the meaningful participation of non-government and people's organization and the private sector in local governance;

**WHEREAS**, the code institutionalized this participation through the creation serve as advisory and recommendatory bodies of every province, cities and municipalities as well as the barangay;

**WHEREAS**, there is a need to organize this council in this municipality and in compliance with the provisions set forth in the Local Government Code 1991;

**NOW THEREFORE I, RONNEL U. LIM**, Municipal Mayor of this Municipality, Province of Sorsogon, by virtue of the power vested in me by law, do hereby order and direct the organization of the Municipal Nutrition Council.

**Section 1.** The Municipal Nutrition Committee is hereby being reconstituted to be composed of the following:

**Section 2.** Duties and Functions. The **MNC** shall have the following duties and functions:

- Prepares Municipal Nutrition Action Plan
- Coordinates the implementation and monitoring of agency nutrition activities
- Conducts periodic visits and meetings with the BNC to assess progress of program implementation.
- Serves as resource person to the barangays.
- Hold regular quarterly meetings.

**Section 3.** There shall be a MTC Technical Working Group/Secretariat designated by the LCE which shall be assisted in its functions and duties by the regular staff of the Committee's Chairman.

**Section 4. Automatic Succession of Members.** In case of resignation, retirement, separation, transfer, re-assignment, removal of member, the successor or replacement shall automatically take the position and serve only for the unexpired term. Provided, that in case of leave or suspension, the replacement shall serve only for the duration of the leave or suspension.

**Section 5. Repealing Clause.** All prior issuances and orders inconsistent with this Executive Order are hereby repealed.

**Section 6. Separability Clause.** In the event that any provision of this Executive Order is held invalid or unconstitutional, the provisions not affected thereby shall remain in full force and effect.

**Section 7. Effectivity.** This Executive Order shall take effect immediately.
