AN ORDER REORGANIZING THE COMPOSITION OF THE HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD (HRMPSB) OF THE LOCAL GOVERNMENT UNIT OF GUBAT, SORSOGON

WHEREAS, Sec 88, Rule IX of the 2017 Omnibus Rules on Appointment and Other Human Resource Actions, provides for the composition of the Human Resource Merit Promotion and Selection Board;

NOW THEREFORE, I RONNEL U. LIM, by virtue of the powers vested in me as the Local Chief Executive of the Municipality of Gubat, Sorsogon, do hereby order the following:

Section 1. Reorganization. – It is hereby ordered to reorganize in the Municipality of Gubat the Human Resource Merit Promotion and Selection Board (HRMPSB) to serve as the recommending body to the Local Chief Executive for the appointment for the vacant positions in the Local Government Unit.

Section 3. Functions and Responsibilities. – The HRMPSB shall have the following functions and responsibilities:

- The HRMPSB shall serve as the recommending body for the appointment. However, final decision on whom to appoint shall be with the appointing officer/authority.
- 2. The HRMPSB shall be primarily responsible for the judicious and objective selection of candidates for appointment in the agency in accordance with the approved Agency Selection Plan and shall recommend to the appointing officer/authority the top five (5) ranking applicants deemed most qualified for appointment to the vacant position.
- The HRMPSB shall maintain fairness and impartiality in the assessment of candidates for appointment. Toward this end, the HRMPSB may employ the assistance of external or independent resource persons and may initiate innovative schemes in determining the best and most qualified candidate.

Section 4. Effectivity. This Order shall take effect immediately.
