EXECUTIVE ORDER NO. 9 Series of 2022

CREATING THE GUBAT FRANCHISING AND REGULATORY BOARD

WHEREAS, Section 1 of Article 1, Chapter 10 of Municipal Ordinance No. 2020-05, otherwise known as the Municipal Traffic and Transportation Code, mandates the creation of the Gubat Franchising and Regulatory Board (GFRB);

WHEREAS, Section 444 (b) (2) (iii) of RA 7160, otherwise known as the Local Government Code of 1991, provides that the local chief executive shall "[i]ssue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances";

NOW THEREFORE, I RONNEL U. LIM, Municipal Mayor of Gubat, Province of Sorsogon, by virtue of the powers vested in me by law, do hereby order the following:

Section 1. Composition. The Gubat Franchising and Regulatory Board is hereby created to be composed of the following:

Section 2. Powers, Duties and Functions of the Board. The Board shall exercise the following powers, duties and functions:

- a. Accept, evaluate, process and recommend to the Sanggunian Bayan the approval or disapproval of applications for the issuance, amendment, revision, renewal, suspension, cancellation, or revocation of Municipal Tricycle Operator's Permit (MTOP);
- b. Determine the number of allowable passengers for each tricycle unit;
- c. Identify different routes within the Municipality of Gubat and to prescribe the appropriate fare rates thereon;
- d. Accept petitions for fare rate increase, conduct public hearings thereon and prescribe appropriate fare rates thereafter subject however, to final approval of the Sangguniang Bayan;
- e. Formulate the proper documentary form to enable it to execute its mandated functions;
- f. Formulate rules and regulations pertaining to the operation of Motorized tricycles, subject to the approval of the Sangguniang Bayan;
- g) Conduct seminar on road safety and traffic rules and transportation ordinances, rules and regulations;
- h) Exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance.
- **Section 3. Secretariat.** The SB Secretariat/Staff shall serve as the Secretary of the Board and provide the latter with administrative, clerical and technical support services. The Secretariat shall accept all applications for the issuance or renewal of MTOPs, including petitions for the amendment, revision, suspension, revocation or cancellation of the same, and submit them to the Board for deliberation and proper action.
- **Section 4. Automatic Succession of Members.** In case of resignation, retirement, separation, transfer, reassignment, removal of a member, the successor or replacement shall automatically take the position and serve only for the unexpired term. Provided further that in case of leave or suspension of the member, the replacement shall serve only for the duration of the leave or suspension of such member.
- **Section 5. Repealing Clause.** All issuances, memoranda and orders issued inconsistent herewith are hereby superseded, repealed and amended accordingly.

Section 6. Separability Clause. In the event that any provision of this Executive Order is held invalid or unconstitutional, the provisions not affected thereby shall remain in full force and effect.

Section 7. Effectivity. This Executive Order shall take effect immediately.
