CONTRACT FORM

THIS AGREEMENT made this 27th day of March, 2023 between **THE LOCAL GOVERNMENT UNIT OF GUBAT** of the Philippines (hereinafter called "the Entity") of the one part and **R. JARABO CONSTRUCTION & SUPPLIES** (hereinafter called "the Supplier") of the other part:

Whereas the Entity invited Bids for certain goods, viz., **CLUSTERED PROJECT: 1) CONSTRUCTION OF PATHWAY, BRGY. TABI, GUBAT, SORSOGON; 2) CONSTRUCTION OF PATHWAY, BRGY. TIGKIW, GUBAT, SORSOGON with reference no. PR-450**, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION-NINE HUNDRED NINETY-FOUR THOUSAND EIGHT HUNDRED SIXTY-THREE PESOS (P1,994,863.00)** hereinafter called "the Contract Price").

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
