**CONTRACT FORM**

THIS AGREEMENT made this 18<sup>th</sup> day of September, 2023 between **THE LOCAL GOVERNMENT UNIT OF GUBAT** of the Philippines (hereinafter called "the Entity") of the one part and **EPP FIRE SAFETY AND RESCUE PRODUCTS CO.** (hereinafter called "the Supplier") of the other part:

Whereas the Entity invited Bids for certain goods, viz., **Supply, Delivery and Commissioning of Rescue Boat with Outboard Motor and Trailer, with reference no. PR1059**, and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION SEVEN HUNDRED TWENTY-EIGHT THOUSAND PESOS (₱1,728,000.00)** hereinafter called "the Contract Price").

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


