

**CONTRACT AGREEMENT**

THIS AGREEMENT made the **6<sup>th</sup> day of December, 2023** between **THE LOCAL GOVERNMENT UNIT OF GUBAT** of the Philippines (hereinafter called "the Entity") of the one part and **ALLEN TRADING** of **Sorsogon City** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Purchase of Equipment and Supplies to be used as tools for teaching and learning process of Gubat South, Gubat North and Gubat III District Schools, with reference no. PR1511** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **SEVEN HUNDRED FIFTEEN THOUSAND EIGHT HUNDRED EIGHTY-FOUR PESOS (₱715,884.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conform thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **SEVEN HUNDRED FIFTEEN THOUSAND EIGHT HUNDRED EIGHTY-FOUR PESOS (₱715,884.00)** or such other sums as may be ascertained, **ALLEN TRADING** agrees to the **Purchase of Equipment and Supplies to be used as tools for teaching and learning process of Gubat South, Gubat North and Gubat III District Schools, with reference no. PR1511** in accordance with his/her/its Bid.
